Privacy Policy for Athlinics

At Athlinics, we are committed to protecting the privacy and personal information of our participants and their families. This Privacy Policy outlines how we collect, use, store, and protect your personal information when you participate in our sports clinic programs. 1. Information We Collect:

1.1 Personal Information:

3. Data Sharing and Disclosure:

3.1 Authorized Personnel:

We may share personal information with our staff members, coaches, and volunteers who require access to this information to ensure the smooth operation of our sports clinic programs and the safety of campers. Our personnel are trained to handle personal information securely and are bound by confidentiality obligations.

3.2 Legal Compliance:

We may disclose personal information if required by law or in response to a valid legal request, such as a court order or government inquiry.

4. Data Security:

We implement appropriate technical and organizational measures to protect personal information from unauthorized access, disclosure, alteration, or destruction. We restrict access to personal information to authorized personnel only, and we regularly review our security practices to ensure the protection of personal data.

5. Data Retention:

We retain personal information only for as long as necessary to fulfill the purposes outlined in this Privacy Policy or as required by applicable laws. Afterward, we securely dispose of or anonymize personal information in accordance with our data retention policies.

6. Consent and Permissions:

By registering for our sports clinic, you consent to the collection, use, and disclosure of personal information as outlined in this Privacy Policy. You may withdraw your consent or request changes to your information by contacting us using the information provided below.

7. Your Rights:

You have certain rights regarding your personal information, including the right to access, update, correct, and delete your information. If you wish to exercise these rights or have any concerns about the processing of your personal information, please contact us using the information provided below.

In certain circumstances, subject to certain exceptions and applicable law, you may have the following rights in relation to personal information about you:

- the right to know (i) the specific pieces of personal information collected; (ii) the categories of
 personal information; (iii) the categories of sources of the personal information: (iv) the business
 or commercial purpose for collecting the personal information; (v) the categories of personal
 information disclosed for a business purpose; and (vi) the categories of third parties with whom
 the personal information is shared;
- 2. the right to have personal information corrected, for example if it is incomplete or incorrect;
- 3. the right to opt out of receiving marketing communications at any time;
- 4. the right to request that personal information is deleted;
- 5. the right to restrict or object to the processing of personal information;
- 6. the right to receive a copy of personal information which you have provided to the firm, in a structured, commonly used and machine-readable format (known as "data portability");
- 7. where you have provided personal information voluntarily, or otherwise consented to its use, the right to withdraw your consent;

8. the right not to be discriminated against if you exercise any rights conferred on you by the

California Consumer Privacy Act of 2018;

9. the right to complain to a Data Protection Authority.
